**I.3. International Symposium** “Interconnectivity in the Mediterranean and Pontic World during the Hellenistic and Roman Periods” (organized in partnership with the National Museum of History and Archaeology of Constanta, Waterloo Institute for Hellenistic Studies, Ontario/Canada and the cultural complex Callatis, Mangalia), July 8-12, 2013, Constanta, attended by all project team members and by 33 foreign researchers from 16 countries. The main purpose of this activity was to present the partial project-related research outcomes (at half way stage of the project), with the subsequent publication of the presented studies in a collective volume (see below

**V.4).** Secondly, by organizing of this scientific meeting we aimed to increase the national and international visibility in achieving the objectives assumed by attracting and involving a greater number of researchers from the country and abroad. We mention here that, in the former project proposal, one of the major objectives aimed our involvement in international dialogue relating the *Polis-*

topic in Hellenistic and Roman times. Thus, we managed to build a network comprising specialists interested in research on the field of Black Sea in antiquity, a network which could lead us towards obtaining EU funded projects. **I.4. International Symposium** “Mobility in Research on the Black Sea Region (PN-II-ID-PCE-2011-3-0054 and PN-II-ID-PCE-2012-4-0490 to H2020)” (organized in partnership with the Iași Branch of the Romanian Academy and the German Cultural Center of Iași), July 6-12, 2015. Among the project team members, the ‘Mobility’ conference brought together 35 scholars from Europe, Asia, and North America, willing to discuss aspects of political, social, cultural, and economic history in Greek, Roman and Byzantine times. The main purpose of this activity was to present the research results obtained so far and prepare these studies for publication in a collective volume (see below

**V.7).** This gathering reflects and exemplifies a tradition of fruitful collaboration between the Institute of Archaeology of Iasi with many academic institutions from Romania abroad. ‘Mobility’ provided plenty of opportunities not only for exchanging updates related to recent literary, epigraphic, numismatic, icono-graphical and archaeological discoveries, but also to share perspectives, methods, and frameworks from which to look at ancient texts and artefacts, whether to gain a better understanding of the past, or to make ancient objects or histories more meaningful for us today. Such meetings firmed up the timeline of the topic, and helped to establish a permanent discussion within a research group focused on the Black Sea region in the ancient world. In that way we gradually developed the idea of an interdisciplinary research network of Romanian and foreign scholars (especially historians, epigraphists, classical archaeologists and

numismatists), which would engage in some large international projects. We would like to emphasize that one of the goals underlined in the project proposal is to develop of an international network on topics related to Black Sea within Greek and Roman times. **II. IX. George Bilavschi and Diana Stah – through continuous support offered to the project director in issues related to management – contributed to the accomplishment of remaining project goals. Based on their contribution a frame for collaboration of the present team members in a larger international context was created. What we mean here is the exploration of possibilities of continuing the current project PN-II-ID-PCE-2011-3-0054 with a funding scheme within H2020 (Horizon2020 Work Programme on the cultural heritage of maritime and coastal zones). At the same time, we focused on the changing dynamics of European Research Policies and their potential short- and middle-term impact on opportunities to reach future resources for our current research endeavors (PC8 – Cooperation, “Idei”, Capacities, and Science in Society). At this point we have already initiated a dialogue with some national and foreign partner institutions on the possibility to implement a European-funded project (*Horizon2020 Work Programme on the cultural heritage of maritime and coastal zones*

) which could bring the research endeavors of the current project to a new level. Likewise, we count on a similarly efficient cooperation we have had so far with the administrative staff of the

Romanian Academy, the Branch of Iasi.

To conclude with, we believe that – in full compliance with the objectives for stage 2013 (correlated with the goals accomplished during stages 2011 and 2012) – we managed to reach the major mid-term goals of our project, namely, publication of a collective work which would reflect, in a more complex and compelling way than before, the external contacts maintained among the urban Pontic communities. The collective volume mentioned earlier – „Poleis”, „Außenbeziehungen”, „Interconnectivity” și „Mobility” – is the best evidence in this respect. By organizing the international meetings (already mentioned at section A.I), which was attended by over 80 specialists from 16 countries and representatives of 46 different research institutions, we managed to convincingly announce our participation in an international prospective dialogue on the Greek polis in the Hellenistic and Roman era.
